5. I enrolled in George Wythe University because it offered an alternative educational model that focused more upon the individual and less upon rigid structures.

6. I knew George Wythe University was not an accredited institution and understood that its unaccredited status could affect the marketability of my educational background.

7. Despite its less than mainstream status, I still chose to enroll myself and my son in the school and I was extremely happy with the education I received there.

8. I attribute a significant amount of the quality education to the foundation established by Oliver DeMille. He is an amazing educator and an inspiring man.

9. I am shocked and saddened by the attacks "my university" has levelled at a person I so deeply admire and am dismayed by the ongoing controversy and discord promoted by the articles on the GWU website.

10. I have personally read the October 16, 2015 article titled "GWU's Final Chapter-The Cleansing of Valid Degrees" and it is my firm desire that the article be removed.

11. I believe this article greatly and falsely maligns Oliver DeMille and Shanon Brooks and continues to promote unneeded and damaging controversy.

12. Moreover, even if GWU's efforts are genuine in trying to preserve the integrity of its student's degrees I believe the article promotes the controversy and discord around the issue and does far more harm than good.
